## **ADMISSION POLICY**

### **PURPOSE**

The purpose of this procedure is to establish clear guidelines regarding admission to various programmes conducted by Hindusthan Institute of Technology (HiTech).

### **SCOPE**

The entry requirements for each course of HiTech are defined in terms of stated qualifications or their equivalents, and are intended to facilitate assessment of the candidate's ability to meet the demands of the course.

The HiTech may require an applicant to submit to an entrance application either through Tamilnadu Single Window Counseling or through Management by Consortium Application. Admission to an appropriate point in a course may be permitted where evidence exists that an applicant has fulfilled particular progression requirements of the course.

### **PROCEDURE FOR B.E / B.TECH ADMISSION**

Admissions are made as per State Government Norms. 65% of seats through Single Window Counseling of Government of Tamilnadu and 35% of seats are filled through the Consortium of Self-Financing Professional Colleges, Tamil Nadu, as per the norms of Government of Tamil Nadu and Committee to regulate the admission process in Tamil Nadu.

### **M.E / MBA / MCA ADMISSION**

50% of seats through Single Window Counseling of Government of Tamilnadu and 50% of seats are filled through Common Entrance Test (CET) by the Consortium of Self-Financing Professional Colleges, Tamilnadu, as per the norms of Government of Tamil Nadu and Committee to regulate the admission process in Tamil Nadu.

## **ELIGIBILITY FOR I YEAR B.E / B.TECH PROGRAMMES**

A pass in HSC (Academic stream) / CBSE / Pre-degree / Plus 2 equivalent school study with minimum eligibility in Mathematics, Physics, Chemistry (Or)

A pass in HSC (vocational stream) with Engineering / Technology as vocational subjects and any 1 or 2 of the related subjects like Mathematics, Physics, Chemistry (Or) any equivalent qualification approved and recognized by the State Board of Technical Education and Training / Higher Secondary Board of Tamil Nadu and Universities in

## **LATERAL ENTRY FOR DIRECT II YEAR B.E/B.TECH PROGRAMMES**

A pass in 3-year Diploma courses conducted by Tamil Nadu State Board of Technical Education or equivalent recognized by the board in pre-final/ final semester of study.

### **ELIGIBILITY FOR M.E - AE / ES / CSE / CS**

A Pass in B.E / B.Tech (EEE / ECE / Electronics / IT / CSE / I&C / E&I, Instrumentation) or M.C.A. or M.Sc. 5 years(IT/ Software Engineering/CS) in regular mode.

### **ELIGIBILITY FOR M.E - CAD / CAM**

A Pass in B.E / B.Tech. (Aero / Mech / MCT / Auto) in regular mode.

### **ELIGIBILITY FOR MCA & MBA**

As per Annexure - II and III respectively for GQ while MQ with Consortium Rank Cards along with other criteria mentioned against government quota without reservation schemes.

### **HOW TO APPLY**

**Management Quota** - Application forms can be submitted online through website of the college or through physical mode by visiting college premises. After on line submission, a printout of the application along with the self-attested copies of the following documents shall be submitted directly or by post so as to reach the College Admission Office before 4 pm on or before the last date.

**For Government Quota** - Allotment Order provided by Directorate of Technical Education, Tamilnadu or by counseling authorities guided by Tamilnadu Government for Higher Education Department, Tamilnadu.

### **Documents to be submitted**

- Qualifying Degree Certificate (for PG Courses) / Diploma (for Lateral Entry)
- Mark lists of each semester of the Degree/Diploma course (for PG & Lateral Entry)
- Mark Sheets of Standard X/XI/XII

- Documents to prove claim for any sort of reservation or special consideration
- Community Certificate
- Transfer Certificate
- Migration Certificate (Other than Tamil Nadu Students)
- Aadhar Card Copy (Indian Citizens) or Copy of Passport for other Nationals
- Online payment /Demand Draft of Rs.500/ - in favor of Principal, Hindusthan Institute of Technology, payable at Coimbatore, Tamil Nadu.

Applications not accompanied by a proof for that claim will not be considered under that category. Late applications/Incomplete applications/ Applications not accompanied by relevant certificates are liable to be rejected, without further intimation to the candidate.

### **ROUNDING OFF OF MINIMUM ELIGIBILITY MARKS**

Rounding off of minimum eligibility marks is not permitted.

### **IMPROVEMENT MARKS**

As per G.O. (Ms.) No.184, Higher Education (J2) Department, Dated: 9.6.2005 and G.O. (St.) No.143, Higher Education (J2) Department, Dated: 6.5.2008 – improvement marks obtained by the candidates from any Board from 2006 onwards shall not be considered.

### **NATIVITY**

- Candidates claiming as belonging to Tamil Nadu will be considered under the respective community on production of necessary Community Certificate, provided they have qualified +2 in Tamil Nadu. Such candidates should fulfil the minimum eligibility marks.
- Candidates claiming Nativity of Tamil Nadu but qualified +2 in other State (including Pondicherry) should produce the Nativity Certificate along with the Community Certificate for consideration under the respective

community. Such candidates should fulfill the minimum eligibility marks.

- Candidates belonging to “Other State” including Pondicherry with Indian Nationality are eligible and treated as “OC” and such candidates should obtain the minimum eligibility marks prescribed for “OC”.

### **Community Certificate**

Tamil Nadu Native candidates who do not produce Community certificate will be treated as “OC”. They should have obtained minimum marks prescribed for “OC” candidates.

### **CALCULATION OF MINIMUM ELIGIBILITY MARKS (OTHER BOARDS)**

If the +2 mark sheets issued by other Boards incorporate both 10+1 and 10+2

### **Document Retention Policy**

Original Certificates will be retained until getting Directorate of Technical Education approval.

### **Reservation Policy**

Seats are reserved for different categories according to TNEA Reservation Policy.
